There are many practical challenges faced by assessee in complying the GST. To address some of the issues and give clarity, the Government has bring out certain changes by way of notifications and circulars. In the month of Dec 2018, 28 notifications and 6 circulars were issued and amendments were made in CGST/IGST Act and CGST/IGST Rules, 2017 and the effective date for the same is 1st Feb'2019. Further GST council in its 27<sup>th</sup> meeting held on 4<sup>th</sup> May 2018 had approved the basic principles of GST return design and in its 28<sup>th</sup> meeting held on 21<sup>st</sup> July, 2018, GST council approved the key features and new format of the GST returns. Further such new forms are expected to be operative on a pilot basis from April 1, 2019, and would be mandated across the country from July'19.
