

Pilot run of Vehicle Number Verification for Karnataka

E-Way Bill system is now integrated with Vaahan system of Transport Department. Vehicle (RC) number entered in e-waybill will be verified with Vaahan data for its existence/correctness. If the vehicle number does not exist, then system will alert the user to check and correct, if required. If the vehicle (RC) number is correct as per the tax payer, then he can continue with generation of E-Way Bill. However, he needs to get the vehicle number updated in the vaahan database so that in future E-Way Bill generation will not be affected.



What is Vaahan?

- It's a website of Ministry of Road Transportation and Highways (MORTH)
- It has a **National Register** where:

Vehicles Data from the **centralized** Vahan 4.0 and **different State Registers** of non Vahan offices situated at respective State Registers flow to the National Register.

Selected information has been envisaged to be captured at the national level. The National Register will act as a **central repository** of all crucial data / information.

What is E- Way bill?

- E-way Bill (EWB) is an Electronic Way bill for movement of goods to be generated on the E-way Bill Portal.
- A GST registered person is required to transport goods in a vehicle following E-way bill provisions contained in Rule 138A/138E of the CGST Rules, 2017.

What is verification of vehicle number in EWB Portal?

- E-Way bill has been **integrated** with Vahan System of Transport Department.
- Vehicle number entered in e-way bill will now be **verified** with the Vahan System.
- If Vehicle no. is not available in the Vahan system user will get 'Alert Message' about the non-availability of vehicle number in vahan database. (visit RTO)
- However, later, such vehicle numbers will not be allowed for the generation of e-way bill.

Types of messages by EWB portal

- "The vehicle number entered in the EWB is not available in Vaahan Database"
- "Vehicle is registered in more than one RTO"

Visit RTO and request for updation.

How do I check my vehicle number is available in Vahan system?

- You can always check your vehicle number in Vahan system below;
 https://vahan.nic.in/nrservices/faces/user/searchstatus.xhtml
- If not found in Vaahan- Visit RTO with RC etc.
- If found in Vaahan but not showing in EWB portal-You can contact the E-way bill Helpdesk and submit your grievance. Specify the Vehicle number which is there in Vahan system but not available in e-way bill portal.

Future???

As per the ET report:-

- The GST e-way bill system is likely to be integrated with NHAI's FASTag mechanism from April to help track movement of goods and check GST evasion.
- One official said "It has come to our notice that some transporters are doing multiple
 trips by generating a single e-way bill. Integration of e-way bill with FASTag would help
 find the location of the vehicle and when and how many times it has crossed NHAI's toll
 plazas,"
